### Case Study 1: ~33% collision frequency reduction with AXA client of 300 LCVs

- In early October 2019, Brightmile was rolled out to an AXA policy holder fleet of ~300 engineers driving LCVs
- Brightmile's intuitive Manager Portal combined with our in-house Customer Success team worked directly with the Group HR Director to ensure minimal effort in deployment
- Brightmile data shows an overall well-performing fleet with positive impact from the outset, as evidenced by the improved claims performance observed since implementation (2020 data obscured by COVID-19)

 The Manager Portal has enabled targeted intervention discussions with outlier drivers to improve specific driving behaviours (e.g. drivers with persistent Speeding or Distraction issues)

## Case study 3: ~10% fuel reduction recorded in company car fleet pilot

- Brightmile is working with the company car fleet of a large logistics provider
- Client has Microlise fleet management in their Commercial Vehicles but no telematics in their cars
- Before proceeding to roll-out, client wanted to conduct a pilot to measure potential fuel savings & quantify the business case
